STATEMENT OF FAITH

1. We believe the Bible (Old and New Testaments) to be the inspired, the only infallible, authoritative Word of God.
2. We believe in one God, eternally existing in three persons: Father, Son and Holy Spirit.
3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, in His present rule as Head of the Church, and in His personal return in power and glory.
4. We believe that man was created in the image of God; that he sinned and thereby incurred not only physical death, but also spiritual death which is separation from God; that all human beings are born with a sinful nature and that those who reach moral responsibility are sinners in thought, word and deed. (This statement affirms our belief that man was created by a direct act of God in His image, not from previously existing creatures, and that all of mankind sinned in Adam and Eve, the historical parents of the entire human race.)
5. We believe that all who receive by faith the Lord Jesus Christ are born again of the Holy Spirit and become children of God.
6. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enable to live a godly life.
7. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation.
8. We believe in the spiritual unity of believers in our Lord Jesus Christ with equality across racial, gender and class differences.



CODE OF CONDUCT

1. I have read and do agree with the Statement of Faith.
2. I understand that this application form is intended for use in evaluating my qualifications for employment. This is not an employment contract. I understand that any false statements, misrepresentations or omissions made during the interview and on this form are grounds for terminating the application process or, if discovered after employment, terminating employment.

I understand and agree that upon breach of this Code of Conduct by myself, that New York GO may terminate my employment at any time, with or without cause, and with or without notice, at the option of New York GO.
6. I authorize New York GO and/or its agents, including consumer-reporting bureaus, to verify any of this information. I authorize all former employers, persons, schools, companies and law enforcement authorities to release any information concerning my background, except as noted in this application, and hereby release any said persons, schools, companies and law enforcement authorities from any liability for any damages whatsoever for issuing this information.
